

**OFFICIAL CONTEST RULES "BUY YOUR CAR WIN YOUR CAR" CONTEST ("CONTEST")**  
**THIS CONTEST IS OPEN TO ONTARIO RESIDENTS ONLY AND IS GOVERNED BY CANADIAN LAW.**

**ELIGIBILITY:**

Contest is open to legal residents of Ontario who: (i) have reached the range of majority in their province/territory of residence at the time of entry; and or (ii) have purchased a new or used vehicle from Parkway Nissan of Stoney Creek (the "Sponsors") during the Contest Period; except employees or agents (and those with whom they are domiciled) of Parkway Nissan of Stoney Creek, its parent companies, subsidiaries, affiliates, distributors, prize suppliers, advertising/promotion agencies and the Contest judges (collectively, the "Contest Parties").

**CONTEST PERIOD:**

**Purchase Method:** You will automatically be entered with one ballot for the draw when you purchase a new or used vehicle from Parkway Nissan of Stoney Creek during the Contest Period. Purchasers will receive **one (1) ballot**, filled out by Parkway Nissan of Stoney Creek with the purchaser's full name, full mailing address including postal code, email address and ten digit telephone number.

**Mail in Method:** To enter without a purchase, print your first name, last name, full home address (including postal code), age, valid e-mail address and ten digit telephone number on a plain white piece of paper and submit it along with a 500 word or more unique and original hand written essay on "The Benefits of purchasing a vehicle from Parkway Nissan of Stoney Creek" (in an envelope with sufficient postage) to: **"BUY YOUR CAR WIN YOUR CAR" C/O Parkway Nissan of Stoney Creek – 191 Centennial Parkway North, Hamilton, ON, L8E 1H8**. Entrants will receive **one (1) ballot**, filled out by Parkway Nissan of Stoney Creek and deposited into the ballot box for one (1) entry into the draw. To be eligible, all mail-in entries must be postmarked during the Contest Period and must be received by no later than November 30 2018. Limit of one (1) Entry per household, regardless of method, permitted during the Contest Period. Sponsor takes no responsibility for any lost, stolen, delayed, damaged, misdirected, late or destroyed mail-in requests. Mechanical reproductions will not be accepted. If it is discovered that you attempted to enter more than once during the Contest Period, then all your Entries will be considered void. Your Entry will automatically be rejected if the entry form is not fully completed and submitted during the Contest Period.

**PRIZE:**

Contest Prize: There will be **one (1) Prize** available to be won, consisting of the value of the winner's vehicle purchase price excluding taxes and extras purchased such as protection packages, extended warranties etc to a maximum of \$50,000. If the winner did not purchase a vehicle, they will receive the average purchase prize of all the vehicles purchased during the contest period excluding taxes and extras purchased such as protection packages, extended warranties etc. Prize must be accepted as awarded with no substitutions. Prize is not transferable. Parkway Nissan of Stoney Creek reserves the right to change, amend or substitute without notice, any or all aspects of the Contest prizing. All other costs and expenses not specifically stated above shall be the responsibility of the winner. The prize must be accepted as awarded, is non transferable, or exchangeable.

**PRIZE WINNER SELECTION PROCESS:**

The prize winner must be present during the draw. A random draw will be conducted at or about 7:30PM (PT) on December 11, 2018 (the "Draw Date") or at the same time of day on a close alternate date at Parkway Nissan of Stoney Creek in Hamilton, ON, by the Sponsor's designated representative, from all eligible entries present that were received during the Contest Period. Before being declared a winner, the selected entrant must first correctly answer, without assistance of any kind, whether mechanical or otherwise, a mathematical skill testing question.
